International, Penn-Jersey Chapter 50 and its members the owners and lessors of premises used to conduct the tournament, their offices, officials, (release), with the respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by negligence of the releases or otherwise, to the fullest extent permitted by law.
