2. I know and freely assume all such risks, both known and unknown, even if arising from negligence of those persons released from liability below and assume full responsibility for my participation; and
3. I will comply with all rules and regulations as stated. If I have any questions or observe any unusual or unnecessary hazards during my participation, I will immediately bring it to the attention of the nearest tournament official, and
4. I, for myself, and the on behalf of my heirs, assigns, personal representative and next of kin, hereby release indemnify and hold harmless the Muskies Inc. International, Penn-Jersey Chapter 50 and its members the owners and lessors of premises used to conduct the tournament, their offices, officials, (release), with the respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by negligence of the releases or otherwise, to the fullest extent permitted by law.
